**APPLICATION FOR HVAC APPRENTICE REGISTRATION**

A person wishing to become an HVAC apprentice shall register with the Division of Building Safety (DBS) prior to going to work and carry a current registration certificate on his person at all times. **You must be eighteen (18) years of age unless registered in a Bureau of Apprenticeship Training (BAT) certified HVAC training program.** Each apprentice shall carry a current registration and shall present it upon request to personnel of the DBS for examination. HVAC apprentice registrations issued or renewed after July 1, 2009, shall be issued for a period of five (5) years.

**Time shall not be credited while the apprentice is inactive or not registered.**

In order to maintain an apprentice registration, an individual must be actively registered with the DBS as an HVAC apprentice, employed by a licensed HVAC contractor, work under the supervision of an HVAC journeyman, maintain enrollment in or successfully complete a training program approved by the board.

In order to qualify to take the HVAC journeyman examination an HVAC apprentice shall be required to work four (4) years under the constant on-the-job supervision of a journeyman electrician and complete an approved training program approved by the board.

**NOTE:** It is the responsibility of the applicant to verify and substantiate all information supplied and to furnish all verifications of employment and schooling.

**APPLICATIONS WILL NOT BE PROCESSED UNLESS COMPLETELY FILLED OUT, SIGNED, NOTARIZED, AND ACCOMPANIED BY THE \$50 REGISTRATION FEE.** Payment may be made in the form of personal check, money order, or cashier's check. All applications paid for with a check will be held an additional 10 business days to allow the check to clear.

**HVAC APPRENTICE PROGRAM**

On July 1, 2004, the state of Idaho's Division of Building Safety (DBS) began the HVAC apprentice program as provided by Idaho Code section 54-1009. This act requires any person who, for the purpose of learning the trade of an HVAC journeyman, engages learning and assisting in the installation, improvement, extension, and alteration or repair of HVAC systems. An HVAC apprentice shall not perform HVAC work except under the supervision of an HVAC journeyman or HVAC contractor.

For advancement in the state HVAC apprentice program, the new apprentice must meet certain requirements to progress toward his journeyman electrician's license. This procedure includes four (4) years of verified work experience under the constant supervision of a qualified licensed HVAC journeyman. Also required are certificates of achievement from postsecondary vocational technical schools or union sponsored training programs. The training required is a minimum of one hundred forty four (144) hours per year for four (4) years of an organized supplemental sequence of instruction in technical subjects related to the trade. The Idaho State system of vocational education postsecondary vocational technical schools are located in six regions of the state of Idaho. These schools are:
