◆ **Vote to authorize Notice of Omnibus Rulemaking – Adoption of Proposed Rule and Notice of Omnibus Fee Rulemaking – Adoption of Proposed Fee Rule with regard to IDAPA 24.39.50, (formerly 07.05.01) in Docket Number 24-0000-2000F**

For administrative rules to continue to be effective, the legislature has to reauthorize them each year. This year, similar to last year, the legislature did not reauthorize any rule that had a fee in it. To ensure the fee rules remain in place, the Governor’s office has promulgated them on a temporary basis. The Board has authority over the rules, and as part of the rulemaking process, DBS asked for approval to place the rules in a proposed state. Once approved, the rules will be published in the Idaho Administrative Bulletin for possible reauthorization at the 2021 legislature.

There has been a structural change within government and DBS is now under the Division of Occupational and Professional Licensing (IDOPL). Therefore, the IDAPA rules under the PWCL Board have been recodified from 07.05.01 to 24.39.50.
