Attending the special meeting via teleconference, Chairman Bob Scott asked Board Member Greg Eagy, who was in attendance at the Division’s Meridian office, to conduct the meeting.

◆ **Vote to Authorize Notice of Omnibus Rulemaking – Adoption of Proposed Rule and Notice of Omnibus Fee Rulemaking – Adoption of Proposed Fee Rule with Regard to IDAPA 24.39.10 (Formerly 07.01.01) in Docket Number 24-0000-2000F**

For administrative rules to continue to be effective, the legislature has to reauthorize them each year. This year, similar to last year, the legislature did not reauthorize any rule that had a fee in it. To ensure the fee rules remain in place, the Governor’s office promulgated them on a temporary basis. The Board has the authority over the rules; therefore, DBS asked for approval to put the rules into a proposed state. Once approved, the rules will be published in the Idaho Administrative Bulletin for possible reauthorization at the 2021 legislature.

The substance of the rules have not changed since presented to the legislature in 2020; however, DBS has been moved under the Division of Occupational and Professional Licensing. Therefore, the IDAPA rules under the Idaho Electrical Board have been recodified from 07.01.01 to 24.39.10.
