These documents are submitted electronically and we need this information to enable those people to do so.

The designation of the 2017 edition indicates that this edition includes the State amendments approved up to and through that year's legislative session. **Idaho Energy Conservation Code:** Idaho uses the 2017 Idaho Energy Conservation Code. This is based on the commercial provisions of the 2015 International Energy Conservation Code and the residential provisions of the 2012 International Energy Conservation Code with the State code amendments incorporated into the text. The designation of the 2017 edition indicates that this edition includes all the State amendments approved up to and through that years legislative session.
