PUBLIC WORKS CONTRACTORS CLASS D LICENSE EXAMINATION

Every Class D applicant filing an original application must complete and return this examination. Your application is considered incomplete without an examination. **To acquire a license, applicants must have a passing score of 70% or higher.**

If you are a partnership or corporation, the responsible managing officer or a member of the staff may complete the examination.

When the qualifying individual is no longer associated with the licensee, the licensee must notify the License Bureau in writing within ten (10) days. The license will remain in force for a reasonable length of time to allow the licensee to find a replacement. Failure to qualify within these guidelines can be grounds for license suspension.
